A RESOLUTION ESTABLISHING THE USAGE AND FEES OF THE MAUPIN CITY PARK EFFECTIVE February 1, 2016

THE CITY OF MAUPIN RESOLVES AS FOLLOWS:

SECTION 1. USAGE. There shall be no vending or soliciting in the City Park for private gain.

SECTION 2. FEES. Fee rates for usage of the park shall be:

RV SITES: Site per day (1 RV + 1 Tent)

Military/Veterans are eligible for Senior Rates
