OPEN BRUSH BURNING PERMIT

GENERAL BURNING PERMIT INSTRUCTIONS - OPEN BURNING REGULATIONS

1. No person shall kindle or maintain any type of open fire or authorize any such fire to be kindled or maintained without a burning permit.
2. Open fires shall be at least 20 feet from any structure. No person shall kindle or maintain any type of open fire within any street or alley right-of-way.
3. All open fires shall be constantly attended by a competent person until such fire is extinguished.
4. Attendant shall have fire extinguishing equipment readily available for use.
5. The fire chief may prohibit any or all open burning when atmospheric conditions or local circumstances make such fires hazardous.
6. Open burning must terminate at 11:00 a.m. from June 1 to July 1. Burning must be out by sundown during the remainder of the permit time period.
7. No plastics, raw garbage, or any other waste matter shall be burned, under permit or otherwise, which shall, in burning, cause or create a dense smoke or offensive odors.
8. No cardboard or paper shall be open burned.
9. **Burning during windy periods is prohibited and all permits are automatically revoked.**
10. Before issuance of burning permit, an on-site inspection may be required by the chief or public works superintendent.

INCINERATOR (BURN BARREL) PERMITS

GENERAL BURNING PERMIT INSTRUCTIONS - INCINERATOR (BURN BARREL) REGULATIONS

1. The incinerator shall be of substantial non-combustible construction and shall be covered with a wire screen having mesh not larger than ¼ inch openings.
2. A minimum clearance of 15 feet shall be maintained between any incinerator and all rubbish, dry grass, weeds, vegetation, and any other combustible material. Incinerator shall not be located any closer than 20 feet from the nearest building.
3. A responsible party shall be in attendance on the property wherever the incinerator is operated.
4. Inspection by the Fire Chief or Public Works Superintendent may be made periodically to determine the adequacy of the installation.
5. Incinerator permit is good for the dates specified above. However, the permit can be revoked for violating the regulations or adverse weather conditions.
6. Incinerator burning must terminate at 11:00 a.m. from June 1 to July 1. The remainder of the time period, burning must be out by sundown.
7. Every incinerator and the equipment thereof, shall be maintained in good condition and repair at all times, and shall be cleaned at least once a month.
8. No plastics, raw garbage, hazardous materials, or any other waste matter shall be burned, under permit or other wise, which shall, in burning, cause or create a dense smoke or offensive odors.
9. No person shall so construct, erect, install, maintain or use any incinerator or barbecue pit, or so burn any combustible material as to constitute or occasion a fire hazard by the use or burning thereof or as to endanger the life or property of any person thereby.
10. Incinerator shall not be located any closer than 5 feet to property line.
11. **Burning during windy periods is prohibited and all permits are automatically revoked.**
