

# CITY OF MAUPIN

ORDINANCE NO: 325

## AN ORDINANCE AMENDING ORDINANCE 314 ADOPTING THE MAUPIN CITY CODE OF 2021, AMENDING AND REPEALING PRE-EXISTING ORDINANCES, SAVINGS CLAUSE AND DECLARING AND ADOPTING ORDINANCE AS EXERCISE OF EMERGENCY POWERS

### RECITALS:

1. The Common Council of the City of Maupin, Oregon, established Ordinance 314 to adopt The Maupin City Code of 2021, which updated and codified the Ordinances of the City of Maupin.
2. Ordinance 314 did not include Planning and Zoning Ordinances.
3. The Common Council of the City of Maupin has determined that the Planning and Zoning Ordinances should be included; therefore, they are adopting this amendment to remove the provisions excluding them, and specifically incorporating them into the Maupin Municipal Code.

### NOW THEREFORE;

**The Common Council for the City of Maupin hereby ordains as follows:**

Ordinance 314 is amended as follows [additions in underline and deletions in ~~strikeout~~]:

1. The City of Maupin hereby adopts the "**MAUPIN MUNICIPAL CODE, A Codification of the General Ordinances of the City of Maupin, Oregon**" as prepared by Code Publishing Company, as attached here to and incorporated herein, as the codification of Ordinances of the City of Maupin with the exception of ~~the Planning and Zoning ordinances and the Local Contract Review Ordinances~~, which shall remain separate from this codification and shall not be affected hereby. The City of Maupin Planning and Zoning Ordinances are hereby included with all other ordinances in the Maupin Municipal Code, A Codification of the General Ordinance of the City of Maupin, Oregon.

2. Hereafter, the attached Maupin Municipal Code shall be known as "**THE MAUPIN MUNICIPAL CODE OF OCTOBER 27, 2021**".

3. **REPEAL OF PRIOR INCONSISTENT ORDINANCES AND UNINCLUDED ORDINANCES AND SAVINGS CLAUSE**

To the extent that any prior ordinances have not been included in this codification (~~other than Planning and Zoning Ordinances and the Local Contract Review Ordinance, which are purposefully excluded~~) and to the extent that any prior ordinances are inconsistent with this codification, such prior ordinances are repealed, PROVIDED HOWEVER, such ordinances shall remain in force for the purposes of enforcing rights, responsibilities and restrictions under such presently repealed ordinance(s), which accrued before the effective date of this ordinance.


4. **EMERGENCY:**

It is hereby determined and declared that the existing conditions are such that the passage of this ordinance is necessary of the immediate preservation of the peace, health, general welfare and safety of the City of Maupin and that an emergency be and the same hereby is declared to exist and this ordinance shall be in full force and effect immediately upon and after its passage by the Common Council of the City of Maupin, Oregon.


5. **INCLUSION IN MAUPIN CITY CODE:**

Upon adoption, the substance of this adopting ordinance shall be included as "Chapter 1.01 - Code Adoption" of the Maupin City Code of October 27, 2021, to which this ordinance relates.
